

One Buck Gang
Updated Rules and Regulations
Effective February 4, 2020
Addition 8-17-2020, Rule 37

1. The One Buck Gang "Senior Official" is Tim Langwald.
2. The One Buck Gang Secretary is Bonnie Webb.
3. Head scorer for 2020 will be JC Hayes. He will have final authority on all scoring. Assistant scorers from the shooters will be selected to assist the Head Scorer. Per the unanimous consensus of the Councilors, the Head Scorer will be able to shoot in any match, if he or she so chooses to.
4. The Range Marshal will be selected prior to the match and will control the shoot.
5. The Target Master will be Jerry Denkhe and will be the only one handling the targets prior to scoring, except as noted in rule 16.
6. Disputes will be decided by the Senior Official and 2 other Councilors.
7. The Sponsor has directed that the Gang be governed by (7) Councilors.
8. Nick Kornick is the Sponsors representative. Nick can and does interject the sponsors' wishes as he sees fit.
9. All new rules, changes and amendments to the One Buck Gang rules must implemented by a quorum of 5 Councilors with 4 voting for the change.
10. All One Buck Gang events and shoots will be at the Rio Grande range unless otherwise noted.
11. At the season end, the One Buck Gang will hold a banquet where qualified shooters and guests will enjoy a meal of some variety and be awarded prizes they have earned.
12. A competition fee of \$1.00 per shooter will be collected at the start of the shoot and be presented to the winning shooter with the highest score for the match.
13. There are no "make up shoots" and there is no "handicap system". Targets will be scored on the actual value of the target as scored and approved by the Head Scorer.
14. The Range Marshal has complete, and total control of the One Buck Gang shoot for the day. No exceptions.

15. For the One Buck Gang shoots, sights for air guns can be open sights, peep sights or red dot sights. "NO" other sights are permitted and "NO MAGNIFICATION" of any kind. Rifles may be checked "AT ANY TIME" for violations before or after a shoot. Violations will result in "disqualification".
16. Targets are provided by the Target Master and must not be handled by the shooter until the targets have been scored, posted. An exception being those shooters selected to assist the Head Scorer grading targets at the end of the match.
17. Each target contains 10 bulls and a "center racetrack" with 2 bulls for practice. If a bull contains more than 1 shot, the highest value will be discarded and the lowest scored.
18. If a target contains more than 10 shots, the target will be penalized/reduced by 20 points per shot in excess of 10.
19. The minimum practice time for shooters will be 10 minutes and will begin after the last match of The Villages Air Gun shoot.
20. The official time will be 3 minutes in the racetrack, then 10 minutes to shoot 10 bulls under the direction of the Range Marshal.
21. In the event of a tie score, the range Marshal will call for a shoot off of one target/one bull, highest score wins. The shoot off will continue until one person wins the shoot off, thereafter collecting the prize money. If two or more shooters score a 100, and a prize of substantial value and variety is at stake, (Henry Rifle or current substitute), the shoot off will consist of a 10 bull shoot off in 10 minutes.
22. Matches will be scored by not less than 2 selected assistant scores and the Head Scorer, the Head having the final resolution of scores. The scores will be posted on a score sheet and posted on a weekly basis on the Air Gun Club bulletin board.
23. If a shooter wishes to appeal his score, he will by a \$5.00 fee to the Range Marshal and if his appeal is upheld his money will be refunded to him. If his appeal is denied, his money goes into the One Buck Gang treasury. The appeal must occur within 10 minutes of the target being distributed back to the shooter.
24. In order to receive a score of 10 the "ENTIRE" center bull dot must be taken out. If any portion of the dot remains, the bull will be scored a 9.
25. All shooters must avoid the scorer's table and do not talk or bother the scorers during the scoring period. Violations may result in the shooter being disqualified.

26. The Head Scorer and Statistician shall each retain a copy of the all scores for the season shoot. The average scores for the season will then determine the prizes to be awarded based on the highest scores presented during the season end banquet.
27. In order to compete for any annual awards, a shooter must compete in 50% of the season matches and have scores to reflect those completed shoots. The Councilors will deal with exceptions such as Snow Birds, Medical Issues and New Members.
28. The shooter with the highest average score at the end of the shooting season will be awarded the One Buck Grand Champion Trophy, which will be theirs to keep permanently.
29. Council information may be conveyed either by e-mail or meetings at the discretion of the Club Senior Official. Scheduled meeting will be as needed.
30. A prize of substantial value and variety will be awarded for a target with a perfect score approved in a regular shoot by the Head Scorer. That score must be 100. Only One Buck "Full Members" are eligible to compete for the (Henry Rifle or current substitute).
Please note: going forward from 7-27-18, Full Members only who shoot a perfect score will be awarded "One Prize Only" during their tenure as a "Full Member" of the OBG.
31. Going forward, those shooters who score 100 (perfect score) will have their rifle immediately inspected to assure that it meets the standards/specifications set forth by the One Buck Gang. This inspection will be performed by Nick Kornick, OBG Sponsor Representative, or the Range Officer.
32. Front Bench Rest will be a ONE POINT REST. Any single point rest that is "commercially" available and "manufactured" by today's standards. Nothing may be added or removed from the rest. "NO CUSTOM-MADE RESTS WILL BE PERMITTED".
33. Inclinable Front Bench Rest Rifle Forearms may be added as long as they meet the guide of no more than 2" wide and no longer than 14 ½.
34. During a match all competitors should remain in their seats, not move around, handle their equipment, talk, whisper, or make noise of any type until the range is called "cold" by the Range Marshal. Violators will be disqualified from that shoot.
35. To be a new member a "Rookie" must be sponsored by an active Councilor of the One Buck Gang, who will be responsible for his or her instruction on the rules of the Club. The person will be proposed to the Councilors and voted on by them, being accepted with a majority vote. Rookies are given a Rookie shirt after 3 shoots in a 4-week period and are in a Rookie status for a period of one year.

36. The 2020 shooting season will begin 2-7-2020 an end on 9-25-2020. The 2021 shooting season will begin the first Friday in October and end on the last Friday in July.
37. All members are required to participate in the club. This includes any position supporting the Club. If a member is asked to volunteer for a task or position, he/she must accept, unless another volunteer accepts the position. Failure to do so could result in removal from the Club by a majority vote of the Councilmen.
